There are **no joining fees** or ongoing costs payable by members for the use of our frameworks. Framework suppliers are required to make payment to Cirrus Purchasing of **0.5%** of invoiced tumover from call-off contracts issued via our frameworks to cover framework management costs.

Environmental Sustainability







